- Tabletop Exhibitors will not hang anything on facility walls, curtains or fixtures. Cost/repair from failure to observe this notice is payable by the Exhibitor (see page 3-4, *Tabletop Guidelines*).
- To ensure focus on the educational program and minimize student distraction, small props, exhibitor displays, banners, table drapers and/or small trade show units are permitted as long as they are confined to the 6' tabletop, unless restrictions are noted prior to the program or requested on site by program instructors and/or CAI-NE staff. Sponsor agrees to abide by all requests regarding display on the day of the program (see page 3-4, *Tabletop Guidelines*).
- Dates/location subject to change

Cancellation Policy

- Sponsor is responsible for the full amount if cancelled within 3 weeks of program date.
- Cancellations received between 3 and 6 weeks prior to program are subject to a cancellation fee of \$100.
- No charge will be assessed for cancellations received more than 6 weeks prior to program date.

Tabletop Guidelines

1. Tabletop Display location will be determined by CAI-NE.
2. Tabletop Display items are permitted and must be confined to the 6' tabletop area and is subject to approval by CAI-NE staff.

- 6' Draped or Skirted Table to display company materials,
- One Tabletop Sign - 8.5" x 11",
- 1 Sponsor Pass

Permitted signs & items provided by Sponsor *See Page 2*

- A** - Branded table drape/runner
- B** - Pull-up Banners (2 max)
- C** - Brochures / Company literature*
*Literature **MUST ONLY** be distributed from the sponsored tabletop.
- D** - Branded giveaways**
**Items cannot conflict with items sponsored through the event.
NO outside food or beverage.

NOT Permitted *See Page 2*

- Constructed back walls or additional flooring
- Display materials other than on table provided
Includes but not limited to: magazine racks, additional tables, video equipment, tradeshow set-ups
- Any hanging/posting of signage/items that might mar or deface, even temporarily, the event space.
The cost of repair of damage from failure to adhere to this policy is payable by the Sponsor.
- Trade Show Set-ups
- Providing your own table/surfaces

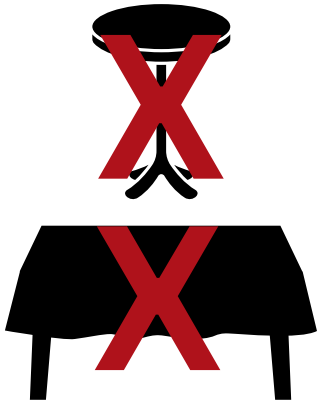

4. Tabletop displays and materials must be dismantled and removed at the designated time and in the manner indicated by the CAI-NE staff after the event.
5. All matters in question not covered by these Guidelines are subject to the decision of the CAI-NE Chapter and all decisions so made shall be binding on all parties affected by them. Authority to enforce these guidelines during the program is vested in the CAI-NE Representative.

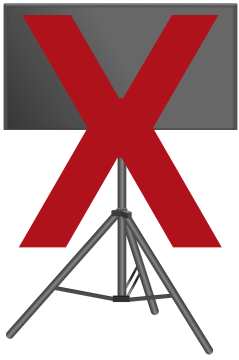
